reason! I fight now, not just for Dr. Okafor, but for any doctor, especially in Ontario, that have been wrongly accused and punished. This expose is for you!

done in ERAS and INDICES. The ERAS will cover Dr OKAFOR's dealings with the CPSO in the order of their occurrence, while the INDICES will present the independent facts of the case in their actual chronological sequence.

First a short introduction of Dr Okafor.

Dr I C Okafor is a veteran of medical practice who graduated from the University of Benin, Nigeria in 1990. He went on to serve a wide swarth of the Nigeria community, in diverse rural and urban settings, until he moved to Canada in 2000 where he promptly set about acquiring his Canadian medical practice Licence.

While challenging the multiple exams in this process he lived in Brampton Ontario working as both a personal support worker with the Brampton Caledon Community Living and the Catholic School Board, first, as a supply teacher and then as an Educational Resource Worker from 2000 to spring 2003. It is noteworthy that the humility of these jobs notwithstanding, he served with compassion and dedication testified to by the fact that the grateful mentally and physically challenged wards and their families he cared for during this period remain dear and supportive friends of his to this day.

He would eventually move to Newfoundland to complete a short residency program and then begin a practice there from 2003 to 2007. He returned to Ontario temporarily in 2007 initially by providing locum coverage in various urban and rural settings of Ontario, from Kapuskasing to Owen Sound, as well as in various walk-in clinics in the GTA before finally settling into the William Osler Hospital in Brampton first in the ER and then as a hospitalist on the rehab floors from 2008. In 2010 he opened a solo family practice just adjacent to the hospital complex. This office was moved to the neighborhood Walmart store in 2015 where he maintained a flourishing practice until 2021. Also, it is noteworthy that along with his hospital and office practice, Dr. Okafor worked with the Ontario house call service, Med-visit. He would jump into a car with a driver, late in the day about 2 to 3 times a week to drive around Mississauga and Brampton, often well past midnight, taking and making calls, and visiting a wide variety of home-bound patients to deliver needed ambulatory care. Note that this disposition to make late calls while riding shotgun with his Med-visit driver was the singular reason for the lateness of a few of his calls, for which he had been exploitatively scandalized by College agents who certainly have access to billing records and therefore to the work-related fact behind the time of those calls, as he vigorously defended in his submissions.

**The ERAs** – Encompassing the phases of Dr. Okafor's dealings with the CPSO chronologically. They reflect the totality of objective records of this case and will be narrated with interjection where needed for emphasis by **Dr. Okafor in the first person**.

**DISCLOSURE:** Any information shared here is from non-medical case records. Apart from medical record confidentiality restrictions, **the agent used in fueling this matter was not a rostered patient of Dr. Okafor but a friend who went rogue with her fantasies, while also enticed by financial gratification, played a minion role in this.**

ERA 1: Written by Dr. Okafor. This begins in 2016, the first time I heard about a report made by Shantel Thomas 4 years prior. The investigator in charge at the time, Mr. Gary Hickey had called my office one day to say he had sent me a letter a few weeks earlier to which he was still awaiting a response. I told him I had not seen it yet but will check for it and get back to him. Days later I did find it in the pile from the Walmart mail office, read it, and called him back. I explained my recollections of this woman to him over the phone and he very nicely let me know that he is retiring that December and would like to get a written response from me on it to enable him to close the file.

I agreed to do so and did: my knight in shining armor letter where I explained that Shantel Thomas was someone I had met non-professionally through her mom, a Nurse colleague from The William Osler Hospital, and subsequently her mom would confide in me that her daughter was a troubled sex trade worker, who works out of town, with a hard-drinking problem, a foul-mouth, and a tendency, amongst other behavioral discrepancies, to lie in her own vomit in the basement when she visited her mother. Horrified (Ms. Pauline was the most pleasant, articulate, genteel Jamaican Canadian I had ever met and this relationship of the seemingly pleasant young lady riding in the front passenger seat of her car when I first met her was a shock), I asked her: “Do you want me to talk some sense into her?” I asked, confident that some serious African-style, hard-hitting, common-sense talk would make an impact on this poor, misguided woman. Ms. Pauline gratefully agreed and gave me Shantel’s number. And so began an informal, long-distance telephone relationship in which she was encouraged to call and ask me for advice at any time it was needed. Now a known acquaintance, Shantel would then drop by my office a few times on a walk-in basis when she came to town to visit her mother: 7 billed visits in total, from

November 2010 to May 2011, she would leave with prescriptions she never filled or used as stated by her during the hearing.

My much maligned and twisted-out-of-context letter therefore clearly explains that: Shantel, was extremely troubled, an exotic dancer by profession with significant behavioral and substance abuse issues, who at the behest of her beleaguered mother I had called upon and counseled severally in the past and who remains a disturbed young lady, with the personality of a dragon, for whom I retained the deepest compassion and would gladly still be a knight in shining armor to if need be. This sense of St George and the Dragon is what would be savagely taken out of context by malicious College agents, who cleverly kept the Dragon references silent and published the shining knight term as a romantic allusion. Mr. Gary Hickey, on the other hand, apparently received my letter with satisfaction and I never heard from him again, and past December 16, the date Gary informed me he was retiring, I concluded, to all intents and purposes, that was the end of the matter.

It is important to note at this point, that Dr. Okafor is a flowery writer, a historian, a poet, and a walking encyclopedia. He is an extremely intellectual being; some of his works can be found online. He has written several articles for newspapers, especially in Nigeria under his pseudonyms without being paid a dime. I will share his work if the situation presents itself.

ERA 2: Written by Dr. Okafor. In 2016, following an incident between my physician assistant (PA), Dr. Afroze S., and a locum pharmacist in the Walmart Pharmacy. Dr (Mrs.) Afroze is a Foreign Medical Graduate from Bangladesh.

On this occasion, the pharmacist, on his first day as locum at the local Walmart pharmacy, had received a patient from an outside office who had a prescription with an error of dosage. He then asked the patient to go to the walk-in clinic for a corrected script. I was away from the clinic at the time with the PA left in charge to offer basic services as this. She duly took a proper, basic history and rewrote the script. However, per standing protocol, did so without a signature, as she is not qualified to sign prescriptions, the standing arrangement with the pharmacy being for the pharmacist to validate all such scripts with me before filling them.

This was this pharmacist's first day and apparently, he had not been made aware of this. Frustrated that he sent a patient in with one script error and she returned with another he barged into the clinic demanding for a signature on the script. Afroze refused, explaining why. He raised such a raucous that his employer, the Walmart store management, forbade him from coming back to work at that store. He would vent his anger over this by sending extremely exaggerated letters to both the College of Pharmacists and the College of Physicians with fabricated allegations that were unrelated to the events of the case.

The College of Pharmacy came and quickly dismissed these allegations as superfluous. My College's agents also paid us a visit during which we explained the entire incident clearly and apparently satisfactorily and they left. We expected this was the end of it. Months later they returned, this time under a different investigator, Ms. Lindsey Thornbull, who came with an aggressive, unsmiling attitude, taking over the consult rooms, and perusing office records. I was aghast. There was no reason for this, for what was obviously a dubious report and my disapproval may have shown in my granting her full access to rooms and records but with a stiff-lipped lack of pleasantries. This tactless display of my displeasure was of course based on a naivety that the CPSO and its operatives are an ethics-bound and truth-powered operation and that no matter what one's countenance was, only truth would ever matter in the end. I now know this, lamentably, to have been a very lethal error."

"Ms. Lindsay would go on to drag on with turning our patients' records upside down, and finding no faults outside of minor, petty departures with the rigors of preferred standards e.g. not writing the length in millimeters of a TB reaction site that tested positive and a few such scanty but accurate visit records would order that I go for several remedial courses, including an opioid prescription course, not for something I did but for what she deemed excessive opioid prescription by a locum physician who covered for me when I was on vacation! Nevertheless, I diligently obliged, completing these obstacle courses and finishing them all. This battering of my practice and resources, stemming from a baseless report, would continue, astoundingly, for years. The blatant victimization of a practice and practitioner which was easily apparent as being above a province-wide average in its professionalism and clinical acumen was well underway."

ERA 3: Written by Dr. Okafor. Mr. Thomas is a Jamaican Canadian Brampton teenage boy who lives with his surrogate mother, (his biological grandmother), Ms. Pauline

Thomas. His biological mother, Shantel Thomas had always lived materially and emotionally apart from him having zero involvement in his life and care.

Mr. Thomas visited the clinic one day late in 2016 on a routine care walk-in, after which he took a brief moment to talk to me about a new app project he was working on. It sounded great. Here was a young risk-prone, black young man hoping to better himself against his difficult life odds I happened to know some app developers in the USA and decided to assist him, on his own recognition. This was not only in line with my long practice of community mentoring and sponsorship but was also a way of proving to myself and exercising my loyalty to the principles of forgiveness and compassion that I have always held dearly.

It was thus to his surrogate parent I placed a call to discuss this and get permission to assist him. I only stopped doing so when Shantel started interfering in late 2017 and exploiting it to resume her incessant calls to me. I therefore told Mr. Thomas I could no longer be available as support on his project. Interestingly the old, presumed rested College 2012 issue, 5 years prior, was at this time resurrected with renewed vehemence and vigor, bringing us, in blatantly contrived and malicious installments, to the present day.

### THE INDICES.

The 'INDICES' encompasses the highlights of the 'ERAS' but in their actual chronological order.

INDEX 1: Year 2010: (As explained in that first letter sent to Gary Hickey in 2016, 4 years after the alleged case was reported) Dr. Okafor is a doctor with a keen sensitivity for the welfare of his people and race in this community and in perfect alignment with his culture when his colleague at the hospital, Ms. Pauline Thomas, shared with him the problem she was having with his wayward adult daughter, who worked and lived outside of Brampton he offered to call and counsel her and acquired her phone number from the mother.

INDEX 2. Telephone counseling sessions with infrequent calls triggered by the woman in question calling for advice on her crisis. Due to the nature of Dr. Okafor's work, the majority of the calls in the only phone record obtained by college investigators happened late at night while he was in transit. This woman had run through multiple phone numbers between 2010 and 2012, as records will show. Despite multiple numbers used between 2010 and 2012, it is interesting we only get to see the record of the 2012 number alone. Why the college investigators did not acquire the phone records of her other phone number(s) remains a misery!

INDEX 3. Dr Okafor's family practice in Brampton began in the summer of 2010; the woman in question made walk-in visits when she was in town. Consistent with the rules for episodic walk-in visits by friends and relatives, per the College's terms and conditions i.e. since she was a social acquaintance she was accorded the proper attention for a walk-in visit. Her first walk-in visit was in November 2010.

INDEX 4. Records show that on the 28th of June 2012, which would have been the 8th of such walk-in visits by the woman in question, Dr. Okafor had cause to stop the visit without taking any notes from her and did not bill for the visit. This has been clearly, and logically, explained by Dr Okafor through his lawyers. He immediately discontinued making a written record of her visit that day, having only written the generic opener notation. "Nil c/o." This notation (which means no new complaint) is used when, upon asking a patient "What brings you here today?" he or she opens for example by saying, "Nothing, really." The doctor puts down "nil c/o," The reason for the visit is perhaps an ongoing issue e.g. a prescription refill. It is the business-minded approach of a busy practitioner who starts making records even while conducting the clinical interview.

When the woman in question then said she was there just to say hello as that was the only way she could actually get to see him, in other words, that she was only there on a social visit, this revealed a risk of her developing a pattern of coming to the clinic for social visits when it should be strictly for medical consults. At this point, Dr. Okafor immediately stopped the visit, erased the opening notation of nil c/o on his electronic pad, and discontinued the encounter. It was this act of aborting a fake visit, in real-time, weeks before any call was made that the College in its wisdom has come to libel his name with "the deletion of medical record!!!" The reader should kindly note that: In the several years of vigorous record review and investigation not one case of actual deletion of records, false billing, or any such malpractices were found in his office records of thousands of patients from multiple treatment settings over 5 years of comprehensive community

medical practice. There can be no clearer, firmer sign of the malice with which this witch-hunting was pursued.

INDEX 5. He then asked her to kindly stop coming to the clinic and to restrict all future conversations to their episodic telephone calls. She agreed and left, and for this reason that visit was not billed as he had not served her professionally in any way, a further demonstration of the ethics of that transaction apparent to all but those bent on destruction! Please tell me, is his clinic a charity organization that offers free healthcare services? How relevant to the case was this visit if I may ask? Why would you now take this one unbilled visit as “deleting record” and use this to libel his good name?

INDEX 6. When the woman in question called Dr. Okafor a few days later while he was at the gym and said she had an urgent request to ask of him, Dr Okafor agreed to meet and told her where he was. She met him at the gym and shared that she is planning to leave her profession, move back to Brampton, and open a hair wig salon business, she was wondering if she could get accommodation with her helpful mentor.

“This bizarre request from someone who had just made me cut short my gym time jarred me and I was admittedly too blunt in my response, especially calling her out on her profession by saying that could never happen in any life. Her dragon-style reaction to this was so shockingly vile and vicious that I decided from that moment to sever all communication with her. Corroborating this, reviews of the phone records obtained by CSPO based on the number she provided to them, which covered till December of that year clearly showed she called my number repeatedly and incessantly for weeks before her call to the College and months after that.” – Dr. Okafor

“It was right after this period of turning down, first of her walk-in visits and then of her long-time phone access to me that she, in true dragon style (predictable from her mother’s heartbreaking testimonials) went on to make her wild card attempt at disparaging my name to the College. It is mind-boggling that this plain, series of events, unblemished by any contradicting evidence, would be hijacked as the sole basis for wrecking the broad-based practice of a conscientious physician.” – Dr. Okafor.

INDEX 7. Again, Roger’s telephone record clearly shows that all further calls by this woman to Dr Okafor even after she made the report to the College, tons of them, were not answers. Also, the call logs before her report show that she called the clinic first with

her new number in May 2012, before she made that call, her last visit to the clinic was in May 2011. The phone number on the clinic file was different from the number used in May 2012, no phone record of her previous number was obtained by CPSO. CPSO claimed that the calls were made extremely late into the night up to 1 am, but they failed to establish that a) the lady in question works at night, b) Dr. Okafor works with med-visit and visits patients at their homes up till this time, c) they failed to print the billing records that would show that the calls to the woman in question were made while he was on route to patients homes, being driven by a driver from one patients home to another. All these records they had access to but failed to include in their report.

INDEX 8. It is important to keep sight of the fact that none of this was reported to Dr. Okafor until 2016!!! Even then, he was not given the full details of the complaint. He was only given the name and asked to send medical notes. Regarding complaints against physicians, the College's own regulation stipulates that: 1. the report must be made in a recorded format by the complainant in writing or electronic format and 2. the physician in question must be informed about this within 2 weeks. Neither of these 'thresholds' were met in this case. The body in charge of ethics in medical conduct would seem capable of warping its rules and regulations at whim. Their agent who came to the clinic back in 2016 on the locum pharmacist matter, obviously was ready for blood because she felt Dr. Okafor was too big for his britches and she could hide behind a trusted body to teach him a lesson. How do you leave such a matter in a Doctor's file since 2012, fail to contact him to inform him, wait until you find him proud, then go after the tortured soul who started the complaint, cajole the soul, when the cajoling didn't work, threaten that soul with jail to come forward? Imagine how easy it would have been to gather evidence against Dr. Okafor on this matter. You only mentioned her name to him in 2016, Four years after????? No! an ear infection prescription for her, as the record will show, which in my opinion suggests kindness to a friend. If only he was wise enough to know there was danger lurking!

b). At the point of sending Mr. Hickey the said letter in 2016 the woman had no further clinical encounter with Dr. Okafor, her last billed encounter was in May 2011. Even per CPSO's own regulations he had no more physician-patient business with her and his statement therein that he will gladly continue to be her knight in shining armor during any true future episodes of existential crisis was very appropriate and not attended by any breach of College etiquette.

Return to INDICES.

INDEX 11. Dr. Okafor would hear nothing more from Gary Hickey and concluded that the veracity and honesty of his written response had been adequate, and therefore discharged the affair from his mind. Nothing further would be heard of this until after the case with my nursing colleague, Mrs. Thomas' grandson. Meanwhile, remediation procedures for the pharmacist case continued with the College. declined to assist any further, and told the son to tell his mother to stay clear. There was never any other intention, other than to offer assistance and support to a young man.

INDEX 14.
